

The following information is provided to clarify the Solicitation and to answer questions submitted by Offerors:

Offeror Question No. 1: Is VoA looking for all support to be conducted over the noted on site periods or does VoA wish support as required in addition to the two week time frame (throughout the period of the BPA)?

IBB Answer No. 1: VoA will utilize the BPA for consulting services on an "as-needed" basis throughout the BPA's period of performance. For example, prior to the Mock Show production there will be a requirement to provide on-site support.

Offeror Question No. 2: It is noted that VoA requires a fixed price response. Would a fixed daily rate with a projected not to exceed be acceptable? This would allow delivery orders against the BPA as noted. The answer to question #1 will have some bearing on this.

IBB Answer No. 2: Your fixed price can be a fixed daily rate; however, a "projected not to exceed" would not be an example of a fixed price, as this price would understandably fluctuate.

Offeror Question No. 3: Since this is a fixed price proposal do you wish us to include expenses or should they be invoiced as incurred? We typically include an estimate of expenses then invoice incurred expenses

IBB Answer No. 3: Price proposals shall be prepared in accordance with FBO notice Part (xiii) Schedule.
