A: The scope of work specifically calls for replacement of light bulbs in offices, corridors, lobbies, rest rooms, and break rooms and lounges. The subject matter is covered under sections 4.2, 4.6.4, and 4.11. Hence, the drill hall/gymnasium is excluded.

Q: Name of the current company

A: Lincoln Training Organization

Q: Do you have or can you supply an estimated annual supplies usage for Toilet tissues, Seat covers, and Paper hand towels.

An answer is not available because the quote for the existing contract was presented as a sum for a specified square footage without a break-down for supply/labor.

Q: The SF or % of tile vs. carpet

An estimate is provided because we do not have exact measurement and/or architectural drawings. Estimate 33,000 SF or 55.63% of carpet.
