14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
 The purpose of this amendment is to correct an administrative error in mod. 2 and clarify the FBO numbering system versus the amendment numbering of the solicitation:
 1-change the marking for the hour and date specified for receipt of offers in Modification number 2, item 11 of SF30, to be "not extended". The submission date and time remains as stated in the original solicitation i.e. closing date is April 22, 2007 and closing time is 10:00 am Cairo Local time.
 Amendment 2, SF 30 is thus modified as follows:
 Item 11, delete the marking in item 11 from "The hour and date specified for Offers X is extended" and replace with "The hour and date specified for Offers X is not extended".
 2- Clarify that:
 -Amendment one appears as "Modification number one" under "Synopsis" on the FBO web-site and was issued on February 22, 07 to correct a computer technical glitch in the solicitation. No change was made to the contents of the solicitation as a result of this amendment.
 -Amendment two appears as "Amendment one" under "Solicitation" in the FBO web-site and was issued on March 28, 07. Changes were made to parts of the RFP as a result of this amendment. Thus, this amendment is number 3.
