2) Encourage offerors interested in responding to this requirement to register with Dun & Bradstreet's Open Ratings to ensure receipt of the summary reports by the Contracting Officer prior to the due date and time for proposal submission;						
3) Revise Section IV. Addendum to FAR 52.212-1 and 52.212-2 – Instruction to Offerors and Evaluation – Commercial Items (SEPT 2006), Paragraph H. Proposal Instruction and Format, (b) Financial Documents, to allow offerors to submit Fully Compiled and Reviewed Financial Statements, including indirect rate structures, that are certified by an outside accountant as part of the annual SBA certification for small businesses, in lieu of audited financial statements;						
4) Remind offerors of the requirements of FAR 52.219-14, which states that "At least 50 percent of the cost of contract performance incurred for personnel shall be expended for employees of the concern"; and						
5) Reiterate that all questions received prior to the due date for questions, February 13, 2008 at 11:00AM EST, will be consolidated and responded to after this date.
