GENERAL INFORMATION

Section M - Evaluation Factors for Award

CLAUSES INCORPORATED BY FULL TEXT

52.212-2 EVALUATION--COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a firm fixed price contract resulting from this solicitation to the responsible offeror whose offer conforms to the solicitation and whose offer represents the best value to the Government shall use the tradeoff source selection process in accordance with FAR 15.101-1 to evaluate offerors' proposals.

The evaluation factors that offerors shall address in their proposal are as follows: 1) Technical Capability; 2) Management Approach; 3) Past Performance; and, Price. The relative importance of these factors: Technical Capability, Management Approach and Past Performance when combined, are significantly more important than Price. As this is a tradeoff source selection, the Government may consider for award an offeror who does not have the lowest proposed price or, conversely, the highest technical rating. If all Technical Proposals are given the same overall evaluation rating and risk assessment rating, then the lowest, reasonable price amongst the proposals prevails.

Technical Capability – This factor evaluates the offerors' capability to provide the line item requirements of this contract based on the offerors' background and experience in providing the products listed in the ELIN attachment herein.

Management Approach – This factor evaluates the offerors' customer service program and the offerors' approach to packing, shipping and delivery of various quantities of musical instruments to Korea, mainland Japan, Okinawa and Guam.

Past Performance – This factor evaluates the offerors' past performance history to determine if the offeror will be able to fill simultaneous orders for large quantities (more than 2 of any one kind) of quality musical instruments. This factor will also evaluate the timeliness of the offeror in shipping orders.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(d) The Government reserves the right to award multiple contracts as a result of this solicitation.

(e) The Government reserves the right to award without conducting discussions with any offerors. Therefore, all offerors are advised to submit their best proposals at the specified deadline date and time for offeror proposals.
