- A. Both the Requirement and the Acquisition Strategy for the procurement of Gaseous Xenon described in Request For Proposal SP0600-07-R-0320 has changed significantly resulting in changes to some clauses and/or provisions. Some of the more significant differences are summarized below:
- a. Anticipated contract type has changed from a Requirements Type Contract to multiple awards of Blanket Purchase Agreements (BPA).
 - b. Clause B1.09-2 has been deleted from SF 1449, Blocks 15 and 20.
 - c. A fourth customer has been added (Wright Patterson AFB, OH). In addition, any new future DESC customers requirements will be met under the resultant BPAs as well.
 - d. The overall Period of Performance is changed to September 1, 2008 through August 31, 2013.
 - e. The Schedule has been revised.
 - f. Clause C900 Statement of Objectives/Work and/or Specifications (Aerospace Energy) (DESC APR 2006) has been revised.


